As to the legal response, at the year of 2000, the UN adopted a bill named Protocol to Prevent, Suppress and Punish Trafficking in Persons, especially Women and Children, which is considered as the first legally binding protocol which made a generally accepted definition for human trafficking and offers a series of protections at the same time. 137 countries signed on the protocol by the year of 2010 since the issue becomes more and more serious (Simmons et al, 2013).
