In North Carolina, victims of car accidents can choose to sue the negligent driver in small claims court. The jurisdiction of a small claims court regarding personal injury and property damage is limited to a maximum of \$10,000, exclusive of filing fees and court costs. According to N.C.G.S. §1-52 (16), the general rule for filing a negligence action or personal injury case in North Carolina is three (3) years from the date of the accident. That means that if a victim was injured on February 1, 2018, that person has until February 1, 2021 to file a lawsuit for their personal injury claim.
